We are thankful that you are once again considering our school for the continuing *academic and spiritual needs* of your child. We know there are other options available, so when you choose to entrust your child into our care we take every step to assure that your child has a quality educational experience that exhibits the *Christ-centered approach* that you have come to expect from our school.

Each year we continue to be committed to raise our educational standards, enhance our academic environment and prepare our students to become the *Christian leaders of tomorrow*.

Tuition for any **additional students** from the same family will be even lower at \$5,500/year for Middle School and \$6,000/year for High School.

As our staff continues to provide what we consider to be the best in quality Christian education, we hope you will agree that this is the best place for your child to attend school in the 2017/2018 school year.

RE-ENROLLMENT REQUIREMENTS

For Middle School and High School
2017-2018 School Year

The following steps **must be completed** to become eligible for re-enrollment at DCCS for the current school year:

- Read and Sign the Statement of Faith (Parent & Student).
- Read and Sign the Standards and Policies.
- Fill out the Emergency Card.
- Complete and sign the Insurance Verification and Medical Information.
- The Tuition Contract should then be filled out and signed.

REVIEW PROCESS

We understand that the re-enrollment of our student is also dependant upon the results of an academic, financial and behavioral review of the previous year at DCCS.

The **Academic Review** includes the current GPA, progress towards successful graduation, academic achievements and the student's personal commitment to educational advancement and learning.

The **Behavioral Review** includes attendance, tardiness, disciplinary referrals, suspensions, classroom attitudes, Christian character, moral values and influences that the student has upon others.

The **Financial Review** includes tuition payment history, ability to fulfill current financial commitments, stewardship and any benevolence that might be available.

The findings of this review and this completed application will determine if Desert Chapel Christian School is best suited to meet the needs of our child.
